COVID-19 RELEASE, ASSUMPTION OF RISK AND INDEMNITY AGREEMENT

In consideration of the above-named person being allowed to participate and compete in the 2021 Central Oregon Pee Wee Rodeo Association (COPWRA) and the undersigned parent(s) or legal guardian of the person, on behalf of the person, and for ourselves, our personal representatives, heirs, spouse, parents, siblings, and children, do hereby:

1. **RELEASE, WAIVE, DISCHARGE AND COVENANT NOT TO SUE** the Central Oregon Pee Wee Rodeo Association, Crook County Fairgrounds, Harney County Fairgrounds, COPWRA Board Members, Directors or representatives of the association or any other rodeo association, managers, agents and employees (all of whom are collectively referred to herein as "Releasees") from any and all liability to the Person, the undersigned, and their personal representatives, assigns, heirs, parents, legal guardians, siblings, and children, and any claims or demands therefore, on account of the Person's or the undersigned's injury, illness, disease or death from the COVID-19 coronavirus, which occurs as a result of the Person's or any of the undersigned's entrance onto the grounds of Crook County Fairgrounds, Harney County Fairgrounds or anywhere COPWRA events take place, as a participant, assistant, parents or otherwise in any event, whether such injury, sickness, disease or death is caused by the negligence or other wrongful conduct of, strict liability or otherwise by, one or more of the Releasees or any person, spectators or other individuals of COPWRA.
2. **AGREE TO INDEMNIFY AND SAVE AND HOLD HARMLESS THE RELEASEES** and each of them from any liability, damage or loss (including, but not limited to, attorneys' fees and other defense costs) one or more of them may suffer or incur arising out of or related to the Person's or any of the undersigned's entry onto the grounds of any COPWRA and/or participation in any of its events, whether such claim is based on one or more of the Releasees' negligence, breach of contract or warranty, strict liability or other legal theory.
